SECTION 4 : FIRST AID MEASURES

4.1. description of first aid measures

Seek medical attention immediately, showing the label.

Rinse mouth thoroughly with water

SECTION 5 : FIREFIGHTING MEASURES

Oxidising mixture which may ignite or increase the risk of flammability when in contact with combustible materials.

Use personal protective equipment that is clean and has been properly maintained.
